			<p>Equipment will be exposed to all weather conditions. Access to equipment is at the boat owner's discretion. Boat owner will be given key access to the pen. Abuse of privilege or negligent practices (i.e. not securing the pen after use) will void storage agreement. Space is not guaranteed and subject to MCYR Head Coach approval. Owner may be required to remove all equipment during special events and / or visiting teams. A 48-hour notice will be given to owner if equipment is required to be moved/relocated. Proof of insurance and liability waiver required.</p> <p><i>Failure to pay voids storage agreement. Owner will have 30 days to claim their equipment.</i></p>
Boat Storage / Rack	Indoor Storage	\$25/month	<p>Boat and Oars (2) will be stored indoors at the Fort Hamer Boathouse location.
